### **CHAIRMAN’S LETTER**

In the July 2011 issue of this newsletter, I provided an update on the SRSRA efforts to stop the proposed changes to retiree medical benefits. Since that report, we met jointly with DOE and the current contractor, Savannah River Nuclear Solutions (SRNS) on August 11. At that meeting, we expressed frustration with the lack of new information that we could share with you, our constituents. This has resulted in Kelly Sanders’ special article, just below my letter, describing the process DOE and SRNS are following to implement the changes.

The SRSRA’s focus continues to be on utilizing the support of the CSRA congressional delegation to help our cause. In response to your letter writing campaign, several of you may have received a reply from SC Senator Lindsey Graham that says in part “I plan on working with the Savannah River Site Retiree Association to ensure that any changes to the health care plans are fair and do not result in a decrease in the quality of life for SRS retirees.” These are encouraging words as Senator Graham had previously agreed to be our champion within Congress. We have had a follow up meeting with the Senator’s staff and are providing him with information needed to apply pressure on DOE. We have now met with eight of the nine members/staffs of the SC/GA congressional delegations (4 US Senators and 5 Congressmen) who were judged critical to our cause. The remaining member we have yet to meet with is Representative Barrow from Georgia. He is having medical issues, so our meeting with him has been delayed. All congressional offices have voiced their support for our efforts to Senator Graham’s office.

Our membership is concentrated in the CSRA and therefore our efforts have been with the CSRA congressional delegation. I, however, recognize that SRS retirees have chosen to retire to areas outside the CSRA. Unfortunately, we are unable to contact every retiree’s US Senator and US Representative. If you live outside the CSRA, I encourage you to continue to communicate your concerns to your Senators and Congressman and encourage them to contact Senator Graham with their support.

We have been posting important information on the SRSRA website, [www.srsretirees.org](http://www.srsretirees.org). We encourage you to look there.

Many of you have seen the news reports of Mr. Dwayne Wilson replacing Gary Flowers as CEO and President of SRNS. We have met Mr. Wilson and he will be at our next meeting with SRNS which is scheduled for October 25.

## **SRNS / SRR UPDATE ON PENDING BENEFITS CHANGE**

The SRS prime contractors, Savannah River Nuclear Solutions (SRNS) and Savannah River Remediation (SRR), have agreed to provide the SRS Retirees Association with updates on the pending changes to our retiree medical benefits. The SRS Retirees Association Board of Directors does not agree with these pending changes and has been meeting with the contractors, the Department of Energy and our Congressional delegation to stop or delay the implementation of these changes. The article below has been provided to us by Kelly Sanders, SRNS Benefits Manager.

### **Retiree Medical Update**

The Health & Welfare Benefits Committees are moving forward with the proposed Retiree Medical changes as previously communicated and scheduled to be implemented January 1, 2013. The procurement process has begun to seek the best providers for our participants. Provider selection will be made in January / February time frame. Then the detailed Plan Design changes and retiree rates will be determined in Spring 2012 with communications scheduled for Summer and Fall 2012. In addition to the written communications that will go to all retirees eligible for the SRNS and SRR retiree medical and dental programs, an important component of the bids will be to include educational sessions for the retirees to explain the changes and ask questions.

### **Shingles Vaccine**

The Shingles vaccine is being strongly promoted in our local area. According to physicians, if an individual has had chicken pox, the shingles virus is similar enough that susceptibility to one means a greater chance of catching the other.

The Site BCBS drug plan covers one routine Shingles vaccination at age 60 or over. If it is received at an in-network physician's office without a scheduled appointment, it would be covered at 90% of the allowed charges. If you were to receive the vaccine at the time of a scheduled office visit of an in-network provider the vaccine would be covered at 100% of the allowance after paying the \$20 co-pay. The vaccination is not covered if administered by an out-of-network provider. Those of us on Medicare must file with Medicare first, because they are considered our primary provider before BCBS will be considered as secondary provider and make payment.

### **Medicare Physicals**

Update regarding physicals for those of us on Medicare. This change began in January 2011. Medicare covers two types of physical exams – one when you're new to Medicare and one each year after that. (Page 39 – Medicare & You booklet)

Within the first 12 months of our beginning on Medicare Part B we can receive a "Welcome to Medicare" physical exam and we pay nothing if we go to a physician who accepts Medicare assignment. You need to let the doctor know you are scheduling a "Welcome to Medicare" physical.

We are also entitled to a yearly "Wellness" exam if we have been on Part B for longer than 12 months. This yearly wellness visit is to develop or update our current health and risk factors. We pay nothing for this exam if the doctor accepts Medicare assignment. This exam is covered once every 12 months. The "Wellness" exam can not take place within 12 months of your "Welcome to Medicare" exam.

Please note that the 12 month interval between physicals must be a minimum of 12 months – 365 days. If you receive the wellness physical on day 364, Medicare will not pay for it. It is also very important to make sure your doctor knows that you are there for either the “Welcome to Medicare” or annual “Wellness” exams. The physician’s billing to Medicare must be specifically coded for these exams, and Medicare prescribes exactly what tests must be run for each and what they will pay for.

### **Problems with BCBS software system**

For those on Medicare it is important to be conscientious about reviewing your MSN’s (Medicare Summary Notices) against your BCBS EOB’s (Explanation of Benefits) especially for those living outside the State of South Carolina. Apparently there is a flaw in the transfer of information between the Medicare and the BCBS software systems when initiated out-of-state. On your BCBS EOB, you will be notified that your charges are out-of-network and are not paid. You need to contact the retirees’ customer service representative listed on our Website to get clarification. ### **SRSEA Announces Long Term Care Insurance Discount Program**

The New York Life Insurance Company has approved offering their Long Term Care Insurance Multi-Line discount program to participants and spouses of the SRSEA. This is the same group discount that is offered to NYL agents. The policies will be individually tailored to meet the needs of a given participant and will require applicants to pass medical and cognitive tests. NYL is developing a page to be located on the SRSEA web-site, but that may take 4-6 weeks for approval and implementation. ### **Two Savannah River Site Projects Gain National Recognition**

SRS has received Environmental Sustainability (EStar) awards from DOE for two projects growing out of technology research, development and application at SRNL.

EStar awards recognize excellence in pollution prevention and sustainable environmental stewardship. They are awarded for projects and programs that reduce environmental impacts, enhance Site operations, and reduce costs.

One award, for Renewable Technology Development, Deployment and Education in South Carolina, is a collaboration between SRNL and the Economic Development Partnership of South Carolina. Through collaboration, SRNL has shared expertise and knowledge of renewable energy technologies with EDP, which in turn has leveraged existing relationships with industry to identify and evaluate specific opportunities. The results have ranged from emissions reductions (through deployment and staging of hydrogen and wind energy technology) to community education programs.

The second award recognized a project to remediate tritium-contaminated debris in an innovative, cost-effective way. SRNL identified and tested technology to remove tritium from contaminated concrete and soil by using a high heat source called a "thermal detritiation unit." Each unit is a concrete block structure housing an array of commercially available heating elements, effectively removing the tritium over a period of time. The treated soil and concrete debris can be disposed at an on-site excavation site rather than sent offsite for disposal, reducing transportation, packaging and disposal costs. Over \$1.6 million in transportation cost savings and an avoidance of 400,000 truck miles were realized from the deployment.

DOE's Steve Mackmull is the federal lead for the site's Pollution Prevention program. John Harley of SRNS is the lead for the contractor organization.

The awards are among 15 granted by DOE out of 186 national entries.

### **SRNS Aids Plan to Ensure New Jobs and Economic Growth in Area Communities**

SRNS is partnering with Augusta Technical College to fill a rapidly growing void for nuclear workers, resulting in qualified candidates for new and existing jobs related to the nuclear industry, fueling area economies.

Flowers explained that SRNS is donating \$10,000 to buy high tech equipment for three new labs at Augusta Technical College (Augusta Tech) that will be used to educate future nuclear workers.

The potential impact of the nuclear renaissance on area economies is huge. South Carolina Electric and Gas has plans for a new commercial power plant, while Plant Vogtle in Waynesboro, Ga., is now in the process of building two new reactor units.

Augusta Tech operates under the supervision of The Technical College System of Georgia which oversees 27 colleges throughout the state. Augusta Technical College offers more than 100 programs of study leading to associate degrees, diplomas and technical certificates of credit. It also provides business and industry training

to area companies either on campus or at the customer's workplace. Augusta Tech is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools.

### **DOE's Excess Property Donation Protects Lives, Property and the Environment**

The recent purchase of new fire engines at SRS resulted in the availability of two excess fire trucks under the SRS Community Reuse Organization's (SRS CRO) Asset Transition Program.

The primary goal of the Department of Energy's (DOE) Asset Transition Program is to utilize excess personal property derived from the Savannah River Site to enhance economic development and job opportunities within a five-county region surrounding the Site. In addition to job creation, assets may also be used to improve the "quality of life" of area residents. Such is the case in the fire truck donation.

These excess fire trucks were made available during a 30-day period only to local fire departments with up-to-date and executable mutual aid agreements with the SRS Fire Department. For this restricted property posting, SRS CRO has waived all transportation, storage, or other related costs for the requested items.

Based upon the most demonstrated need per the information supplied to the SRS CRO, the Allendale County Fire & Rescue was selected to receive one of these trucks. The fire department intends to use the donated truck to benefit the entire county of Allendale by lowering the current Insurance Service Office rating for its citizens. The requested property will be an addition to the existing fleet and would serve multiple substations being established in the outer limits of the county. The goal is to place the requested property in one of these locations so that this new apparatus would be available for use in fire suppression to an area that does not currently have such equipment.

As DOE's designated Community Reuse Organization (CRO), the SRS CRO is a 501(C)(3) private non-profit organization and is governed by a 22-member Board of Directors composed of business, government and academic leaders from Georgia and South Carolina. The mission of the SRS CRO is to facilitate economic development opportunities associated with SRS technology, capabilities and missions and to serve as an informed, unified community voice for the five-county, two-state region. These counties are Aiken, Allendale and Barnwell in South Carolina and Richmond (Augusta) and Columbia in Georgia.

### **SRS Environmental Bioassay Laboratory Support Aids Japan**

On March 11, 2011, an earthquake and a tsunami wave triggered a string of disasters in Japan that created an outpouring of relief efforts to assist the Japanese people.

SRS's Environmental Bioassay Laboratory (EBL) was one U.S. asset that played a key role in the Department of Energy Consequence Management Home Team's (CMHT) response to assist the Government of Japan, by analyzing soil and air filter samples for radiological contaminants related to the Fukushima Daiichi reactor incident. The EBL is one of the first SRS capabilities to play a specific role in the Japan effort.

The primary objectives of the CMHT's sample collection, sample analysis, and data assessment teams were to evaluate personnel exposure hazards, identify the nuclear power plant radiological source term and plume deposition, and assist the Government of Japan in assessing any environmental and agricultural impacts associated with the nuclear event. CMHT personnel and the Japanese government collected the samples for analysis and shipped them to SRS for analysis.

The EBL analyzed approximately 250 samples and reported approximately 500 analytical method determinations. Samples sent to the EBL were primarily soil samples from farmland surrounding the Fukushima reactors or air monitoring samples of national interest, including those collected at the U.S. Embassy

and American military bases. Since the soil samples were from Japan and might contain foreign microbes, they had to be processed, treated, and analyzed under a special permit from the United States Department of Agriculture. Samples were analyzed for a wide range of radionuclides, including strontium-89, strontium-90, gamma-emitting radionuclides, and plutonium, uranium, americium and curium isotopes. The rapid reporting of high quality analytical data was critical to allow the government of Japan and CMHT to evaluate radiological impacts from the nuclear reactor incident to both personnel and the environment.

The EBL was selected as one of four laboratories nationally to perform these sample analyses due to its expertise in rapid analytical methods for radiological contaminants in environmental samples. The Lab was contacted via Lawrence Livermore National Lab, because of its membership in the National Analytical Management Program, a DOE-sponsored organization that coordinates analytical services and capabilities within the DOE complex and within other federal agencies. EBL is an active member of a laboratory consortium that provides a nationwide, integrated system to assist with response to environmental and radiological emergencies such as the Japanese reactor incident. The EBL is operated by SRNS.

### **Savannah River National Laboratory Named a National Safety Council Industry Leader**

The National Safety Council announced that Savannah River National Laboratory, operated for the U.S. Department of Energy by Savannah River Nuclear Solutions, has been honored with a 2011 Industry Leader Award. The award is a component of the Council's Safety Motivation and Recognition Awards Program. The award benchmarks outstanding safety achievements among member companies based on self-reported data.

Savannah River National Laboratory is one of 52 organizations honored with the 2011 Industry Leader Award, which recognizes the top 5 percent of NSC members that have qualified for the National Safety Council's 2011 Occupational Excellence Achievement Award. To receive the Industry Leader Award, member companies, units and facilities must have 0 cases and 0 fatalities during the 2010 calendar year, and demonstrate safety performance that is among the best within their North American Industry Classification code.

SRNL was one of 10 Industry Leader Award winners in the Professional, Scientific and Technical Services classification.

### **TRUPACT-III Has Arrived, Completing Over 10 Years of Efforts**

After 10 years of working and waiting, many E-Area personnel left their offices to watch the arrival of the long-awaited TRUPACT-III shipping container from Washington State, and even more employees watched a few days later as the loaded container left for the Waste Isolation Pilot Plant (WIPP) in New Mexico.

The TRUPACT-III shipping container will be used to transport legacy TRU waste from SRS to WIPP. This Department of Transportation Type B cask allows the shipment of a single large volume container, the Standard Large Box 2 (SLB2), which is approximately 6 x 6 x 8 feet and holds a volume of 6.6 cubic meters of waste materials.

Using the TRUPACT-III shipping system will allow for the disposition of 1,700 of the 5,000 cubic meters of legacy TRU waste planned under the American Recovery and Reinvestment Act (ARRA), which would have otherwise required additional time and resources for size reduction to fit into the smaller containers suitable for TRUPACT-II. By avoiding this, SRS significantly reduced physical and radiological worker exposure to highly contaminated TRU waste materials.

This TRUPACT-III container is the first of six funded by ARRA to be used by the SRS, and it carried the first of approximately 250 planned shipments. The shipments are scheduled to occur every two weeks, and the TRUPACT-II containers will continue to be used as well. After completion of the legacy TRU waste project in

Fiscal Year 2013, the fleet will be made available to other Department of Energy sites for their disposal programs.

Until then, the TRUPACT-III will be a significant addition to the legacy TRU waste program at SRS.

### **Savannah River Remediation Begins School Year With Outstanding Report Card**

As school bells begin ringing across the CSRA, Savannah River Remediation (SRR) has an outstanding report card on its education outreach efforts during the past year, according to Dave Olson, SRR President and Project Manager .

SRR has accomplished much on its most recent report card by offering internship opportunities, scholarships, funding and personal time to students in the surrounding communities.

SRR's most recent accomplishment has been the Summer College Internship Program, which gives college students a taste of what it's like to work in the "real world." Olson expressed great enthusiasm about the program because it provided the students with knowledge and experience they would not have otherwise.

SRR hosted 47 college students in its summer internship program. Interns worked in a wide range of disciplines, including Computer Science, Design Authority, Engineering, Finance, Health Protection, Public Affairs, Human Resources, Legal and Project Controls.
